- Facing up to your own physical and mental limits and overcoming them by cooperating in the effort: testing your individual limits and going beyond them by mutual support within the group.

Description of the ECUEs

ENGLISH:

- Preparing for a presentation with visual support (body language, voice management, oral expression, etc.)
- The business world
- Fair trade and sustainable development
- Preparing for certification

GERMAN:

- Basic vocabulary and grammar, communicative situations from everyday life (beginner level)
- Revision/expansion of everyday communication skills, revision/consolidation of basic grammar, CV, covering letter (intermediate and advanced level)
- Business communication, technical German (basics) (advanced level)

SPANISH:

- Acquire linguistic, communicative and cultural skills in order to apply them to social and professional life, with the aim of guiding learners towards independence.

ACCOUNTING:

- Accounting basics: balance sheet, income statement, trial balance, basic accounting entries, VAT, invoices, fixed assets, depreciation, provisions.

- Cost analysis: break-even and marginal cost.
- Cash flow budgeting.

SOCIAL AND ENVIRONMENTAL RESPONSIBILITY:

- Environment and sustainable development: definitions, history and issues
- Raising awareness of major environmental impacts
- Carbon impact and the Kaya equation

HUMAN ORGANISATION OF COMPANIES:

- Definition and analysis of the company: main characteristics and different conceptions of the company, methods of analysis; organisational doctrines and work organisation models.
- Company structures: Types of structure & representation, Design and implementation of structures, Criteria for structuring the company: content and choice, evolution and methods of analysis
- Corporate Management & Management: Decision-making models, management styles,
- Internal control within the company: Internal control procedures: components, obstacles & limits Techniques for assessing internal control (description and systems evaluation)

FAPSA: Main content: Implementing a project - Group cohesion

- Implement a project in which sporting performance is essentially based on the cohesion of the group and requires mutual support between its members.
- Take into account the strengths and weaknesses of each individual to achieve a collective sporting performance.
- Supporting and encouraging each other through effort and difficulty.
- Conferences planned (3h CM): "Can we move our limits", Mental preparation, Testimony of an ultra-trailer...
- Examples of physical sports and artistic activities that can be used as a support: Trail, Mountain bike touring, 24h rollerblading, Bike & Run, Supervision of people with disabilities, etc.
